NEW MLS FEATURE—REPORT LISTING VIOLATION

In the upper right corner of a Listing Detail screen is a new link to click to report a listing violation for that specific listing. By clicking the Report Violation link, an email is generated to board to which the listing broker belongs. Complete the Violation Description area then click the Send E-mail button. Be aware that each of the SWMRIC member boards have their own rules for listing entry. Your board may require room dimensions, another may not. Violation reports are not anonymous.
