CODE OF ETHICS & STANDARDS OF PRACTICE CHANGES

Standard of Practice 3-2.

To be effective, any change in compensation offered for cooperative services must be communicated to the other

REALTOR® prior to the time that REALTOR® submits an offer to purchase/lease the property. (Amended 1/10)

Standard of Practice 3-9 (NEW). REALTORS® shall not provide access to listed property on terms other than those established by the owner or the listing broker. (Adopted 1/10)
